The Pharmacy Examining Board considered this matter at its meeting on September 14, 2011.

PROCEDURAL HISTORY

On October 29, 2008, the Board issued a Final Decision and Order suspending Ms. Kimball's license to practice as a pharmacist in the State of Wisconsin, Pharmacist license number 14533-40. On March 20, 2009, the Board stayed that suspension subject to certain conditions.

On April 20, 2010, the Board issued an Order denying Ms. Kimball's petition to reduce the number of drug screens per year to seventy-five (75) and allow her to work as a pharmacist in charge for 20 hours per week. The Board further ordered her to: submit documentation explaining her missed calls to the approved drug and alcohol monitoring program; submit copies of all prescriptions for medications which were active during the period of the Order; and immediately comply with all written work report requirements.

On June 17, 2010, the Board issued an Order denying Ms. Kimball's petition to reduce the number of drug screens per year to seventy-five (75) and further denied her petition to work as a pharmacist in charge.

On October 4, 2010, the Board issued an Order granting Ms. Kimball's petition to reduce the number of drug screens to not less than forty-eight (48) times per year with one (1) annual hair test. The Board granted her petition to work as a pharmacist in charge for 12 hours per week.

On May 2, 2011, the Board issued an Order granting Ms. Kimball's petition to reduce the required therapy to two times per quarter.

Based thereon, the Board makes the following:

FINDINGS OF FACT

- 1. On or about August 24, 2011, Ms. Kimball petitioned the Board to modify the Order by increasing the pharmacist in charge hours allowed.
- 2. On September 14, 2011, The Board reviewed Ms. Kimball's petition and all of the information of record, including a supporting letter from Ms. Kimball's therapist. The Board

determined that Ms. Kimball was in compliance with the terms of the Final Decision and Order dated October 29, 2008 and the Orders Granting Modification dated October 4, 2010 and May 2, 2011. As a result, the Board granted Ms. Kimball's August 24, 2011 petition for modification. Based upon all the information of record, the Board finds that the Orders below are necessary to ensure the safety and protection of the public, and orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Bonny M. Kimball's petition to be permitted to work as a pharmacist in charge for twenty-four (24) hours per week is hereby Granted. Paragraph C.22. of the Final Decision and Order dated October 29, 2008 shall be modified to remove the prohibition against Ms. Kimball being employed as or working as a pharmacist in charge. All other provisions of Paragraph C.22. of the Final Decision and Order shall remain in full force and effect.

Bonny M. Kimball shall be in full compliance with this Order, the Final Decision and Order dated October 29, 2008 as amended, and the Orders Granting Modification dated October 4, 2010 and May 2, 2011, as amended by this Order.
