On November 3, 2008, the Barbering and Cosmetology Examining Board ordered Respondent to pay costs and a forfeiture in the total amount of \$1,000.00 within 60 days from the date of the Order. On May 23, 2011, finding that Respondent had failed to pay the required costs and forfeiture within the time limit, the Board suspended Respondent's Barbering and Cosmetology Manager's license until the full amount of the costs and forfeiture plus interest of \$121.67, for a total of \$1,121.67, was made.

On June 1, 2011, Respondent petitioned the Board to stay the suspension of his license, and to allow him to pay his costs/forfeiture/interest obligation in installments. Having considered Respondent's petition, the Board grants his request.

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of Respondent's Barbering and Cosmetology Manager's license (# 30700-81) is stayed effective immediately. The Board orders Respondent to make 12 equal monthly payments to the Department until the total amount of his obligation is satisfied. Said payments shall commence the month of July, 2011. Any failure to comply with the terms of this Order will result in the immediate lifting of the stay of the license suspension without further notice or order of the Board.
