On September 1, 2011, the Board of Nursing considered the petitioner's request for reinstatement of his surrendered registered nurse license pursuant to the Final Decision and Order of the Board dated November 5, 2009. Based upon the information of record, including the psychological evaluation dated July 13, 2011, the Board now finds and makes the following:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the registered nurse license of Patrick Lavoie, R.N. (#143233-30) is GRANTED.

IT IS FURTHER ORDERED that the following limitations and requirements shall be placed upon Patrick Lavoie's registered nurse license for an indefinite period of time, which shall be not less than two years:

- 1. Petitioner shall practice only under the direct supervision of a licensed nurse or other licensed health care professional in any worksite whether civilian or military.
- 2. Petitioner shall practice only in a work setting pre-approved by the Board or its designee. Military employment does not require Board approval.
- 3. Petitioner shall provide a copy of the psychological evaluation, completed by Jacqueline Bienek dated July 13, 2011, immediately to supervisory personnel at all settings, including military or civilian, where Petitioner works as a nurse currently or in the future for use in following the monitoring recommendations within the evaluation, including: ability to follow protocols and medical orders; consistent evidence of sound judgment and patient care; accurate documentation; chart reviews; evidence of consistent ability to work cooperatively with peers and supervisors; and appropriate interpersonal skills and attitudes with staff and patients.
- 4. Petitioner shall arrange for written reports from supervisors, including civilian or military, to be provided to the Department Monitor on a quarterly basis.
- 5. Petitioner shall report to the Department Monitor any change of employment status, residence, address or telephone number within ten business days of the date of a change.

6. Petitioner shall commence and continue in therapy or other mental health treatment through a licensed mental health professional. He shall arrange for written therapy reports to be provided to the Department Monitor on a quarterly basis.
