On June 1, 2009, the Barbering and Cosmetology Examining Board ordered Respondents to pay costs and a forfeiture in the total amount of \$1,600.00 within 150 days from the date of the order. On May 23, 2011, finding that Respondents had failed to pay the required costs and forfeiture within the time limit, the Board suspended Respondent Stallworth's Barbering and Cosmetology Manager's license and Respondent D'Zire's Barbering and Cosmetology Establishment license until the full amount of the costs and forfeiture plus interest of \$121.67, for a total of \$1,721.67, was paid.

On June 3, 2011, Respondents petitioned the Board to stay the suspension of their licenses, and to allow them to satisfy the costs/forfeiture/interest obligation in 12 equal monthly payments. Having considered Respondents' petition, the Board grants their request.

### ORDER

NOW, THEREFORE, IT IS ORDERED that the suspensions of Respondent Stallworth's Barbering and Cosmetology Manager's license (# 28652-81) and Respondent D'Zire's Barbering and Cosmetology Establishment license (# 33711-80) are stayed as of the date of this order. The Board orders Respondents to make 12 equal monthly payments to the Department until the total amount of this obligation is satisfied. Respondents' payments shall commence the month of July, 2011. Any failure to comply with the terms of this order will result in the immediate lifting of the stays of suspension without further notice or order of the Board.
