The Real Estate Appraisers Board considered this matter at its meeting on February 23, 2011.

BACKGROUND

On February 25, 2009, the Board issued a Final Decision and Order with regard to disciplinary proceedings against Mr. Counard, a Certified Residential Appraiser, License Number 9-1310. The Board's order required him to complete no less than sixty (60) hours of remedial education, all to be completed within 15 months of the February 25, 2009 Order.

On December 30, 2010, the Board issued an Order immediately suspending Mr. Counard's license to practice as a Certified Residential Appraiser due to a violation of the February 25, 2009 Board Order in that he had not completed the ordered remedial education.

Mr. Counard has now completed the ordered remedial education and on or about February 8, 2011, Mr. Counard petitioned the Board to remove the limitation on his license and grant him full licensure.

Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Alvin Counard's petition to remove the limitation on his license and grant him full licensure, be and hereby is, Granted.

IT IS FURTHER ORDERED that all encumbrances, limitations or restrictions on Alvin Counard's license are hereby Removed.
