On January 27, 2011, Megan Frohmader appeared before the Board of Nursing to provide information pertaining to the Board's consideration of a violation of the Final Decision and Order dated May 7, 2009. The stay of suspension granted the Board of Nursing effective March 25, 2010 provided that the stay is continuous contingent upon her compliance with the terms and conditions of the Final Decision and Order. Based upon the information of record which shows that the petitioner has not been in compliance with the terms and conditions of the Order due to failure to submit reports, the Board now finds and makes the following:

#### <u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and the registered nurse license of MEGAN FROHMADER, R.N. (#149909-30) is SUSPENDED.

IT IS FURTHER ORDERED that before a future petition for a stay of suspension will be considered by the Board, Megan Frohmader shall demonstrate compliance with her Order, including submission of therapy reports, proof of attendance at AA/NA meetings and updating contact information.

This Order is effective five (5) days from the date signed to allow for mailing.
