The Medical Examining Board considered this matter at its meeting on June 15, 2011.

**BACKGROUND**

On June 20, 2009, the Board issued a Final Decision and Order suspending Dr. Erlemeier's license to practice medicine and surgery in the State of Wisconsin, license number 33685. The Board further ordered prior to any petition for reinstatement, Dr Erlemeier shall undergo a comprehensive mental and physical evaluation to demonstrate he is fit and competent to resume the practice of medicine with reasonable skill and safety to patients.

On or about May 18, 2011, Dr. Erlemeier petitioned the Board for return of full licensure status of his license to practice medicine and surgery. Dr. Erlemeier and his attorney appeared before the Board, on June 15, 2011, in support of his petition.

Based upon all the information of record, including a comprehensive assessment and Minnesota Board of Medical Practice Order granting an unconditional license, the Board orders the following:

**ORDER**

**NOW, THEREFORE, IT IS ORDERED** that Steven Erlemeier's petition for a return to full licensure status of his license to practice medicine and surgery in the State of Wisconsin, be and hereby is, Granted.

**IT IS FURTHER ORDERED** that all encumbrances, limitations or restrictions on petitioner's license are hereby Removed.
