On January 27, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated July 23, 2009, to decrease the frequency of urine screens and removal of worksite restriction to allow agency or PRN. Based upon the information of record which shows that the petitioner has been in compliance with the terms and conditions of the Order to warrant partial modification, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitations upon the registered nurse license of ELIZABETH FORWARD, R.N. (lic. # 112040-30) to allow her to work at one agency at only one pre-approved worksite or PRN is GRANTED.

IT IS FURTHER ORDERED that petitioner may not work more than 16 hours per week at the second position.

IT IS FURTHER ORDERED that petitioner's request to have her drug screens decreased is DENIED due to length of time under the order.
