The Pharmacy Examining Board considered this matter at its meeting on June 1, 2011.

BACKGROUND

On September 23, 2009, the Board issued a Final Decision and Order suspending Ms. Orth's license to practice as a pharmacist in the State of Wisconsin, license number 14955. The Board granted a stay of the suspension effective May 14, 2009 contingent upon maintaining compliance with the terms and conditions in the September 23, 2009 order. On September 22, 2010, the Board removed the stay and her license reverted to suspended status. Prior to petitioning for the stay to be reinstated, Ms. Orth must demonstrate three months of compliance with the provisions in the September 23, 2009 order.

On or about April 6, 2011, Ms. Orth petitioned the Board for a stay of the suspension and to modify the Order by reducing the frequency of drug screens.

Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Ms. Orth's petition for a stay of suspension, be and hereby is, Granted.

IT IS HEREBY FURTHER ORDERED that Ms. Orth's petition for a reduction in the frequency of drug screens per year, be and hereby is, Granted.

Paragraph C.14 of the Final Decision and Order shall be changed to read: The Approved Program shall require the testing of urine specimens at a frequency of not less than 48 times per year. The Approved Program shall also require the testing of a hair sample at a frequency of not less than 1 time per year. The frequency of such testing may be further

reduced only upon a determination by the Board or its designee after receiving a petition for modification as required by Paragraph D.4. of the Final Decision and Order.
