On July 6, 2011, the Dentistry Examining Board issued its Final Decision and Order in the above-captioned matter, revoking Respondent's license to practice dentistry in Wisconsin. By its authority under s. 440.22, Wis. Stats., the Board also ordered, that Respondent pay the costs of this proceeding. On or about July 11, 2011, the Dentistry Examining Board received an affidavit of costs in the amount of \$4,228.08, filed by the prosecuting attorney, Arthur Thexton. On or about July 18, 2011, the Board received affidavits of costs in the amounts of \$1,159.00 and \$259.25 filed by Administrative Law Judges Amanda Tollefsen and David R. Braithwaite of the Department of Administration, Division of Hearings and Appeals. The Dentistry Examining Board considered the affidavits of costs on September 7, 2011, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the combined amount of \$5,646.33, as set forth in the affidavits of costs of Attorney Arthur Thexton and Administrative Law Judges Amanda Tollefsen and David R. Braithwaite, attached hereto and made a part hereof, are assessed against Respondent. **Failure to pay the full amount assessed on or before December 5, 2011 shall constitute a violation of this Order unless Respondent petitions for, and the Board grants, a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Safety and Professional Services may not restore, renew, or otherwise issue any credential to Respondent until she has paid the full amount assessed.
