Casimer S. Kobylinski, D.C, (Respondent) was reprimanded and had limitations placed on his license by the Wisconsin Chiropractic Examining Board (Board), by order dated November 12, 2009. By Petition For Termination of Monitoring and Return to Full Licensure dated December 24, 2010, the Respondent asked the Board to remove the limitation from his license, thereby restoring his license status to full licensure. The Respondent's request was considered by the Board at its January 27, 2011 meeting. After review and consideration of this matter, the Board found that the monitoring period as set forth in the November 12, 2009 Order was reasonable and sufficient to promote and protect the public interest.

THEREFORE IT IS HEREBY ORDERED that the Respondent's request for the termination of the independent monitoring requirement and reinstatement to full licensure is denied.
