On May 6, 2010, the Wisconsin Board of Nursing granted Michelle Svoke an initial stay of the suspension of her nursing license, (#151661-30), effective May 3, 2010, pursuant to the Board Order dated January 28, 2010. Information has been received by the Department Monitor that Michelle Svoke is in violation of the January 28, 2010 Order.
