On March 24, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated January 28, 2010 to decrease frequency of AA/NA meetings, therapy sessions and drug screens and termination of annual hair test requirement. Based upon the information of record which shows compliance with the terms and conditions of the Board Order and support of her therapist, the Board now finds and makes the following:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitation upon the registered nurse license of JOAN SABLJAK, R.N. (#12415-31) to decrease the frequency of AA/NA meeting attendance to six (6) times per month, decrease the frequency of therapy sessions to once every three (3) weeks and decrease the frequency of drug screens to twenty-eight (28) times per year with one (1) annual hair test is GRANTED.

IT IS FURTHER ORDERED that the request for modification of the Board Order to terminate the requirement of an annual hair test is DENIED. The annual hair test is a part of standard testing protocol, however, the hair may be taken from any location of her body other than her head.
