On January 27, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated May 6, 2010, to decrease the frequency of urine screens until she finds employment as a licensed practical nurse and allow her therapist to perform the collection and testing of her drug screens. Based upon the information of record which shows that the petitioner has been in compliance with the terms and conditions of the Order but that her therapist is not a board-approved drug and alcohol monitoring program, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitations upon the licensed practical nurse license of SHEENA CLAYTON, R.N. (lic. # 310596-31) to decrease the petitioner's urinalysis screens to fourteen (14) times per year with one additional annual hair test, until such time as petitioner is employed as a nurse is GRANTED.

IT IS FURTHER ORDERED that petitioner's urinalysis screens will be increased to 48 times per year with one additional annual hair test upon employment as a licensed practical nurse.

IT IS FURTHER ORDERED that petitioner's request to have her drug screens completed by her therapist is DENIED.
