On July 21, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated May 6, 2010 to decrease the frequency of her drug screens and allow her access to controlled substances in the practice of nursing. Based upon the information of record which shows irregularities (dilute and abnormal) in her drug screens, the Board now finds and makes the following:

### <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for modifications of the Board Order restrictions upon the registered nurse license of Jill M. Gustafson, R.N. (#202186-30) to allow her access to controlled substances in the practice of nursing and decrease the frequency of drug screens is DENIED.

IT IS FURTHER ORDERED that Petitioner shall provide to the Department Monitor a letter from her medical provider explaining her dilute and abnormal drug screens and a list of her current prescriptions.

IT IS FURTHER ORDERED that Petitioner shall submit to the Department Monitor a written explanation for not testing positive on her drug screens for the medications she has been prescribed.
