ORDER REMOVING STAY OF SUSPENSION

On July 22, 2010, the Wisconsin Board of Nursing granted Respondent an initial stay of the suspension of his nursing license, (#84091-30), pursuant to the Board Order dated July 22, 2010 ("Order"). The stay of suspension was contingent upon Respondent's compliance with the terms and conditions of the Order.

Information received by the Department Monitor indicates that Respondent has violated several provisions of the Board's Order. Respondent failed to enroll and participate in a drug and alcohol monitoring program as required by the Order to begin on the effective date of the order. At least two (2) enrollment packages were sent to the Respondent since the inception of the Order advising him of the procedure for enrollment. Secondly, Respondent has worked as an RN without supervision and in a capacity that was not approved by the Board. Finally, information received by the Department Monitor indicates that Respondent was terminated from this nursing employment as a result of possible diversion of controlled substances from the facility.

Pursuant to section B.2 of the Order, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Randy J. Cornell's registered nurse license (#84091-30) is SUSPENDED for an indefinite period.

IT IS FURTHER ORDERED that Respondent may not petition the Board for a stay of suspension until Respondent has submitted proof to the satisfaction of the Board, or its designee, that he has been in compliance with the provisions of Sections C and D of this Order for six (6) consecutive months prior to the request for a stay.

This Order is effective five (5) days from the date hereof.
