On August 18, 2010, the Medical Examining Board (Board) issued a Final Decision and Order suspending the license to practice medicine of Steven L. Armus, M.D., (#34598-20) for an indefinite period of time but imposed an immediate stay of that suspension based upon compliance with certain conditions and limitations. One such condition required Dr. Armus submit to drug screening forty-eight times per year.

On or about October 14, 2011, Dr. Armus, petitioned the Board for a modification reducing the number of drug screens from forty-eight times per year to thirty-five times per year. On November 16, 2011, the Board considered the petitioner's request. Based upon the information of record, the Board now finds and orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification reducing the number of drug screens from forty-eight times per year to thirty-five times per year of Steven L. Armus (20-16638) be, and hereby is, Granted.
