On September 13, 2010, the Barbering and Cosmetology Examining Board ordered Respondent to pay costs/forfeitures of ONE THOUSAND NINE HUNDRED AND FIFTEEN DOLLARS (\$1,915.00), in an installment plan whereby payments would be made every 90 days.

Information has been received by the Department Monitor that Respondent is in violation of the Barbering and Cosmetology Examining Board Order by failing to pay costs and/or forfeitures in accordance with the payment plan.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the Respondent's Barbering and Cosmetology Establishment licenses (#33899-80, 35199-80) are SUSPENDED until Respondent has complied with payment of costs and/or forfeiture.

This Order is effective as of April 27, 2011.
