On November 1, 2010, the Barbering and Cosmetology Examining Board filed its Final Decision and Order in the above-captioned matter by which the Board ordered that pursuant to s. 440.22, Wis. Stats., the costs of this proceeding be assessed against Respondent. On or about November 8, 2010, pursuant to s. RL 2.18 (4), Wis. Admin. Code, the Barbering and Cosmetology Examining Board received the Affidavit of Costs in the amount of \$668.17, filed by Attorney Heather Curnutt. On or about November 8, 2010, the Board received the Affidavit of Costs of the Division of Hearings and Appeals in the amount of \$164.70, filed by Administrative Law Judge Amanda Tollefsen. The Board considered the Affidavits of Costs on September 12, 2011, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to s. 440.22, Wis. Stats., the costs of this proceeding in the combined amount of \$832.87, set forth in the Affidavits of Costs of Attorney Jeanette Lytle and Administrative Law Judge Amanda Tollefsen, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by Respondent to the Department of Safety and Professional Services. **Failure of Respondent to make payment on or before November 11, 2011, shall constitute a violation of this Order unless Respondent petitions for and the Board grants a different deadline.** Under s. 440.22 (3), Wis. Stats., the Department of Safety and Professional Services may not restore, renew or otherwise issue any credential to the Respondent until Respondent has made payment to the department in the full amount assessed.
