The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Regulation and Licensing ("Department"). The Department Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent Barbara A. Hosen (dob 10/18/1983) is licensed in the State of Wisconsin as a Private Security Person, having license number 108-36010, first issued on 06/03/2008 and current through 08/31/2012. Ms. Hosen's most recent address on file with the Department is W8573 Benton Street, Briggsville, WI 53920.
- 2. On or about July 6, 2010, Ms. Hosen submitted a renewal application and answered "No" to the following question:

Have you been convicted within the past two years of a felony, a misdemeanor or a violation of any state or local law (other than traffic) that is punishable by a forfeiture, or, are charges pending? (If Yes, provide information.)

- 3. A Criminal Information Bureau check revealed convictions for Ms. Hosen within the two years preceding July 16, 2010. The Department subsequently opened a case for investigation.
- 4. Court records obtained during the course of the Department's investigation revealed that on or about July 15, 2010, Ms. Hosen was convicted of a forfeiture offense, Operating While under the Influence (1st).
- 5. Ms. Hosen failed to notify the Department of the conviction within 48 hours after the entry of the judgment of conviction.
- 6. In resolution of this matter, Respondent Barbara A. Hosen consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The State of Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in paragraph 2 of the Findings of Fact, Respondent Barbara A. Hosen has violated Wis. Admin. Code § RL 35.01(17) by providing false information in the application for a credential.
- 3. By the conduct described in paragraph 4 of the Findings of Fact, Respondent Barbara A. Hosen has violated Wis. Admin. Code § RL 35.01(2) by engaging in conduct which reflects adversely on her professional qualification.
- 4. By the conduct described in paragraph 5 of the Findings of Fact, Respondent Barbara A. Hosen has violated Wis. Stat. § 440.26(4m)(b) and Wis. Admin. Code § RL 35.01(2) by failing to report her conviction within 48 hours of the judgment of conviction.
- 5. As a result of the violations noted in the Conclusions of Law, Respondent Barbara A. Hosen is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)1, 2, 3, and 4.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent Barbara A. Hosen (license number 108-36010) is hereby REPRIMANDED.

- 2. Within ninety (90) days following the date of this Order, Respondent Barbara A. Hosen shall pay COSTS in the amount of ONE HUNDRED FIFTY-FIVE DOLLARS (\$155.00).
- 3. Payment of the costs shall be made by check payable to the Wisconsin Department of Regulation and Licensing and sent to:

- 4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent Barbara A. Hosen fails to timely submit payment of the costs as ordered and as set forth above, Respondent Hosen's license (number 108-36010) may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
 - 5. This Order is effective on the date of its signing.
