The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Martha's Hair, Skin, Nails & Boutique is licensed in the state of Wisconsin as a barbering and cosmetology establishment, license number 80-15693. This license was first granted on 03/01/1985 and is current through 03/31/2011.

2. The most recent address for Martha's Hair, Skin, Nails & Boutique on file with the Wisconsin Department of Regulation and Licensing (Department) is 4804 W Burleigh Street, Milwaukee, WI 53210.

3. Martha J. Watts is licensed in the state of Wisconsin as a barbering or cosmetology manager, license number 81-14651. This license was first granted to Ms. Watts on 7/17/1979 and is current through 03/31/2011. Ms. Watts is the owner of Martha's Hair, Skin, Nails & Boutique.

4. Ms. Watt's most recent address on file with the Department is 4800 W Burleigh Street, Milwaukee, WI 53210.

5. On March 25, 2010, a Department Investigator performed an inspection of Martha's Hair, Skin, Nails & Boutique.

6. At the time of the inspection, Martha's Hair, Skin, Nails & Boutique was renting a booth to Jagruti Khatri for Ms. Khatri to provide facial threading services. Ms. Khatri is not licensed in the state of Wisconsin and did not have an establishment license for her rental.

7. In resolution of this matter, Respondents Martha's Hair, Skin, Nails & Boutique and Martha J. Watts consent to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in paragraph 6 of the Findings of Fact, Respondents Martha's Hair, Skin, Nails & Boutique and Martha J. Watts violated Wis. Admin. Code § BC 2.04(1) by permitting an unlicensed individual to perform threading services;

3. As a result of these violations, Respondents Martha's Hair, Skin, Nails & Boutique and Martha J. Watts are subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The barbering or cosmetology manager license of Martha J. Watts (license number 81-14651) and the barbering and cosmetology establishment license of Martha's Hair, Skin, Nails & Boutique (license number 80-15693) are hereby REPRIMANDED.

IT IS FURTHER ORDERED that:

2. Respondent Martha J. Watts shall, within one hundred twenty (120) days from the date of this order, pay a FORFEITURE in the amount of FIVE HUNDRED DOLLARS (\$500.00). Respondent Martha's Hair, Skin, Nails & Boutique shall, within one hundred twenty (120) days from the date of this order, pay a FORFEITURE in the amount of FIVE HUNDRED DOLLARS (\$500.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondents' licenses. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondents fail to timely submit payment of the forfeitures as ordered and as set forth above, the Respondents' licenses (numbers 81-14651 and 80-15693) may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondents have complied with payment of the forfeitures.

4. This Order is effective on the date of its signing.
