On February 17, 2011, the Real Estate Board issued its Final Decision and Order in the above-captioned matter, by which the board ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against Respondents. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about February 22, 2011, the Real Estate Board received an affidavit of costs in the amount of \$2,169.51, filed by Attorney Lydia Thompson. On or about February 24, 2011, the Real Estate Board received an affidavit of costs in the amount of \$433.10, filed by Administrative Law Judge Amanda Tollefsen of the Department of Administration, Division of Hearings and Appeals. The Real Estate Board considered the affidavits of costs on April 28, 2011, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the combined amount of \$2,602.61, set forth in the affidavits of costs of Attorney Lydia Thompson and Administrative Law Judge Amanda Tollefsen, attached hereto and made a part hereof, are hereby assessed against Respondents, and shall be payable by Respondents to the Department of Regulation and Licensing. **Failure to pay the full amount assessed on or before June 30, 2011 shall constitute a violation of this Order unless Respondents petition for, and the Board grants, a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew, or otherwise issue any credential to Respondents until Respondents have paid the full amount assessed.
