The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Real Estate Appraisers Board (the "Board"). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# FINDINGS OF FACT

- 1. Respondent Charles Glassing (Date of Birth: November 22, 1946) is licensed in the state of Wisconsin as a Certified General Appraiser and Licensed Appraiser, license number 10-727. This license was first granted to Mr. Glassing on July 17, 1995, and it is current through December 14, 2011. Mr. Glassing's license was expired from December 15, 2009, through July 20, 2010.
- 2. Mr. Glassing's most recent address known to the Department of Regulation and Licensing (hereinafter Department) is 6440 Flying Cloud Drive, Suite 119, Eden Prairie, Minnesota 55344.

3. Prior to December 14, 2007, the Department sent Mr. Glassing a Certified General Appraiser and Licensed Appraiser Renewal Application to execute and return with the required fee if Mr. Glassing wished to renew his license in the state of Wisconsin for the December 15, 2007 through December 14, 2009 biennium. Mr. Glassing elected to renew his license using the on-line Renewal Application form available at the Department's website. The on-line Certified General Appraiser and Licensed Appraiser Renewal Application contained the following language:

"I have completed 28 hours of Department-approved education credits, including at least 7 hours in the Uniform Standards of Professional Appraisal Practice (USPAP), between January 1, 2006 and December 14, 2007. I have evidence of this which I will furnish to the Department upon request."

- 4. Mr. Glasing electronically filled out the on-line Certified General and Licensed Appraiser Renewal Application on or about November 5, 2007, certifying that he had completed the continuing education requirements of the Board during the January 1, 2006 through December 14, 2007 biennium.
- 5. As part of a random audit that the Board conducted of its licensees, Mr. Glassing was sent a letter requesting that he send the Board verification that he had completed the 28 hours of approved continuing education.
- 6. Mr. Glassing submitted documentation that he had completed 48.5 hours of continuing education hours during the January 1, 2006 through December 14, 2007 biennium. Some of the courses completed by Mr. Glassing, however, were not approved by the Department. Mr. Glassing completed only 7.5 hours of approved continuing education during the January 1, 2006 through December 14, 2007 biennium.
- 7. Mr. Glassing did not complete the required 28 hours of approved continuing education during the January 1, 2006 through December 14, 2007 biennium.
- 8. Mr. Glassing made a material misstatement on his November 5, 2007 on-line Certified General Appraiser and Licensed Appraiser Renewal Application when he attested that he had completed 28 hours of approved continuing education during the January 1, 2006 through December 14, 2007 biennium.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Real Estate Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 452.14, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Pursuant to Wis. Stat. § 440.08(2)(a)11, each person possessing a license to practice as a Certified General Appraiser and Licensed Appraiser in the state of Wisconsin must renew the license biennially, by December 15 of each odd-numbered year.

- 3. By failing to have completed at least 28 hours of Department approved continuing education in the previous biennial registration, Mr. Glassing violated Wis. Admin. Code § RL 85.01(1).
- 4. As a result of the violations in paragraph 3 of the Conclusions of Law, Mr. Glassing is subject to discipline pursuant to Wis. Stat. § 458.26(3)(i).
- 5. Because he made a material misstatement in his application for renewal of his license, Mr. Glassing is subject to discipline under Wis. Stat. § 458.26(3)(a).

## **ORDER**

#### NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The license and certification of Respondent Charles Glassing (license number 10-727) is hereby REPRIMANDED.

#### IT IS FURTHER ORDERED that:

- 2. The license of Respondent Charles Glassing (license number 10-727) is hereby LIMITED as follows:
- a. Charles Glassing shall, within one year of the date of this Order, successfully complete 20.5 hours of approved continuing education under Wis. Admin. Code, ch. RL 85, including taking and passing any exam offered for the courses. This continuing education shall only be applied to the credit hours Mr. Glassing should have obtained during the January 1, 2006 through December 14, 2007 biennium.
- b. Charles Glassing shall submit proof of completion in the form of verification from the institution providing the education to the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any post 2006-2007 biennium continuing education requirements that have been or may be instituted by the Board or the Department of Regulation and Licensing.
- c. The Limitations shall be removed from Charles Glassing's license and Charles Glassing will be granted a full, unrestricted license after satisfying the Board or its designee that he has successfully completed all of the ordered continuing education.
- 3. Charles Glassing shall, within 120 days of the date of this Order, pay COSTS of this matter in the amount of NINE HUNDRED AND THIRTY DOLLARS (\$930.00).

4. Proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Regulation and Licensing) shall be mailed, faxed or delivered by the Respondent to the Department Monitor at this address:

- 6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Charles Glassing's license to practice in the state of Wisconsin as a Certified General Appraiser and Licensed Appraiser (license number 10-727). The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Charles Glassing fails to comply with payment of the costs and completion of the continuing education portion of this Order, Charles Glassing's license to practice in the state of Wisconsin as a Certified General Appraiser and Licensed Appraiser (license number 10-727) may, in the discretion of the Wisconsin Real Estate Appraiser Board or its designee, be SUSPENDED, without further notice or hearing, until Charles Glassing has complied with all the terms and conditions of this Order.
  - 7. This Order is effective on the date of its signing.
