**PROCEDURAL HISTORY**

Due to a scrivener's error, the previous order # 0000694 dated February 24, 2011, incorrectly referred to the licensee as a licensed practical nurse and incorrectly referred to paragraph 3 of the findings of fact within the conclusions of law. Accordingly, this order is issued *nunc pro tunc* to correct the omission and replace the first order # 0000694 dated February 24, 2011.

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Laurie J. Glowac (dob: 5/14/58) is and was at all times relevant to the facts set forth herein a registered nurse licensed in the State of Wisconsin pursuant to license #30-83731, and working for the Dane County Jail. This license was first granted on 12/30/82. Her address listed in the Board's records is 4472 Celestial Circle, Cross Plains, WI 53528.

2. Between June 18, 2010 and June 20, 2010, and while practicing nursing as a staff nurse at the Dane County Jail, Respondent diverted 5 vials of injectable lorazepam, a Schedule III

controlled substance, for her personal use. Respondent has been diagnosed with substance addiction.

**CONCLUSIONS OF LAW**

A. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07(1)(b), (c) and (d), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

B. The conduct described above, violated Wis. Adm. Code §§ N 7.03(2) and N 7.04(2). Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.


**ORDER**

IT IS ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, effective the date of this Order, the SURRENDER of the license to practice nursing of Laurie J. Glowac, R.N., is ACCEPTED. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact.

IT IS FURTHER ORDERED, that Respondent shall pay costs of \$200.00, to the Department of Regulation and Licensing, within 60 days of this Order.
