#### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

### **FINDINGS OF FACT**

1. Crystal A. Vista, (DOB 01/08/1959) was formerly licensed as a practical nurse in the State of Wisconsin (license # 31-309837). This license was first granted on April 17, 2008, and expired on April 30, 2009. Pursuant to Wis. Stat. § 440.08, Respondent may renew her license upon payment of a fee until April 30, 2014.

- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is N 7550 Lucas Road, Felch, Michigan 49831.
- 3. On or about November 24, 2009, Respondent was disciplined by the Michigan Board of Nursing for repeated medication administration errors. Respondent was put on probation and required to take continuing education and submit work reports.

# **CONCLUSIONS OF LAW**

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraphs 3 above constitutes a violation of Wisconsin Administrative Code §§ N 7.03(1) and N 7.04(7), and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(c) and (d).

# **ORDER**

#### IT IS ORDERED:

- 1. The SURRENDER of Crystal A. Vista of her right to renew her license to practice nursing in Wisconsin upon payment of a fee is hereby accepted.
- 2. The SURRENDER of Crystal A. Vista of her privilege to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.
- 3. In the event that Respondent re-applies for licensure as a nurse in in Wisconsin the future, the Board may limit that license to address the findings of fact based upon this stipulation, without further notice or hearing, and Respondent hereby expressly waives all rights to a hearing on any such limitation.
- 4. Respondent shall, within ninety (90) days from the date of this Order, pay costs of this proceeding in the amount of Two Hundred Dollars (\$200.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:
