PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Dr. Ollisoji O. Oyesanya, M.D., Respondent, date of birth November 30, 1955, is licensed and currently registered by the Wisconsin Medical Examining Board to practice medicine and surgery in the state of Wisconsin pursuant to license number 30809, which was first granted October 26, 1989.
- 2. Respondent's address of record with the Department of Regulation and Licensing is 7735 S. Sanctuary Road, Franklin, WI 53132.
 - 3. Respondent's practice specialty listed with the Department is Family Practice.

- 4. Respondent was employed as a physician in Milwaukee, County, Wisconsin. Although Respondent is a family practitioner, over time his practice evolved to include a high proportion of pain management and patients with opiate addiction.
- 5. Respondent is retiring from the practice of medicine and surgery and will not resume active practice in this or any other jurisdiction. Consistent with his retirement, he will also immediately surrender his DEA registration. He has knowingly, willingly and voluntarily agreed to these Findings of Facts and the following Conclusions of Law as legally valid and sufficient to justify the terms of this Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3) and authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 2. This Order and its terms are warranted by application of Wis. Admin. Code § MED 10.02(2)(h) and Wis. Stat. § 448.02(3).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that, in anticipation of his RETIREMENT, the permanent SURRENDER by Dr. Ollisoji O. Oyesanya, M.D., Respondent, of his license and registration to practice medicine and surgery in the state of Wisconsin, including his right to renew the credentials, is hereby ACCEPTED.

IT IS FURTHER ORDERED that Respondent shall, within 30 days of the date of this Order, submit proof, acceptable to the Board or its designee that he has surrendered any and all DEA registrations, as well as staff privileges at any and all health care facilities at which he previously held privileges.

IT IS FURTHER ORDERED that documents and payments due pursuant to Wis. Stat. § 440.22(2), shall be mailed or personally delivered to the Department of Regulation and at:
