PROCEDURAL HISTORY

The parties in this matter agree to the terms of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

The Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Mark A. Melton, (D.O.B.: February 15, 1977) is duly licensed as Clinical Substance Abuse Counselor in the state of Wisconsin (license # 15396-132), which was first granted on June 10, 2009. Respondent is also licensed as a Substance Abuse Counselor-in-Training in the state of Wisconsin (license # 15639-130), which was first granted on September 4, 2008.
- 2. Respondent's most recent address as determined by the investigation of this case is 223 Turtle Creek Drive, Apt. #1, Delavan, WI 53115.

- 3. Respondent was employed by Walworth County Department of Health and Human Services as a Clinical Substance Abuse Counselor from approximately September 2008 to November 2, 2009.
- 4. In September of 2009, Patient N.N. presented to the Respondent for outpatient substance abuse group therapy. The group met approximately four times per week on a weekly basis between September of 2009 and November 2, 2009, at which time the Respondent's employment was terminated.
- 5. On January 2, 2010, Respondent and Patient N.N. began a romantic relationship. Since that date Respondent and Patient N.N. have engaged in a sexual relationship and reside at 223 Turtle Creek Drive, Apt. #1, Delavan, WI 53115.
- 6. Respondent is currently working as a personal property lien salesperson. He wishes to surrender his licenses as Substance Abuse Counselor-in-Training and as a Clinical Substance Abuse Counselor.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing has jurisdiction over this matter pursuant to Wis. Stat. § 440.88 and has authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent's conduct above constitutes a violation of Wis. Admin. Code § RL 164.01(2)(m), and subjects Respondent to discipline pursuant to Wis. Stats. § 440.88(6).

ORDER

IT IS ORDERED:

- 1. The Department accepts the surrender of the certificates of Mark A. Melton to practice as a Substance Abuse Counselor-in-Training (# 15639-130) and as an Clinical Substance Abuse Counselor (# 13596-132) pursuant to Wis. Stat. § 440.08. In the event that Respondent attempts renew his Wisconsin credentials in the future, the Department may enter an order denying such application, in its discretion, without further notice or hearing.
 - 2. This Order is effective on the date of its signing.
