PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Sharon Ann Holm, L.P.N., (D.O.B. 4/3/1949) is licensed as a practical nurse in the State of Wisconsin (license # 31-8310). This license was first granted on 12/20/1968.

- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is N730 Big Kegama Lake Rd. Sarona, WI 54870. Upon information and belief, Respondent currently resides at 310 Scheidler Rd. #3 Chippewa Falls, WI 54729.
- 3. While employed at the Marshfield Clinic office in Chippewa Falls, Wisconsin, Respondent called in or faxed prescription orders for drugs to pharmacies in or around the Chippewa Falls and Rice Lake areas in Wisconsin for herself or her husband, without physician orders. Respondent did so on numerous occasions over an approximate five (5) year period.
 - 4. Respondent was convicted of possessing/illegally obtaining prescription drugs.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraphs 3-4 above constitutes a violation of Wisconsin Administrative Code § N 7.04(1) and (2) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1).

ORDER

IT IS ORDERED:

- 1. The SURRENDER of the license of Sharon A. Holm to practice nursing in the State of Wisconsin is hereby accepted.
- 2. The SURRENDER of the privilege of Sharon A. Holm to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.
- 3. In the event that Respondent ever reapplies for licensure as a nurse in Wisconsin the Board may limit that license to address the findings of fact based upon this stipulation, without further notice or hearing, and Respondent hereby expressly waives all rights to a hearing on any such limitation. Further, Respondent shall, prior to such application, pay costs of this proceeding in the amount of Two Hundred Dollars (\$200.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:
