PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Pharmacy Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Paul Schlondrop, R.Ph. ("Respondent") was born on May 6, 1971, and is licensed to practice as a pharmacist in the state of Wisconsin pursuant to license number 13328-040. This license was first granted on October 12, 2000.

2. Respondent's most recent address on file with the Wisconsin Department of Regulation and Licensing is W180 N5156 Marcy Road, Menomonee Falls, Wisconsin 53051.

3. At all times relevant to this proceeding, Respondent was working as a pharmacist at Walgreens, store number 03578, located at 2275 N. Mayfair Road, Wauwatosa, WI 53226.

4. In April 2010, patient "C.B." was prescribed Levetiracetam 100mg/ml, 1.1ml to be taken orally, twice per day. The prescription was filled as 100mg/ml, 5.5ml, taken orally, twice per day.

5. From April 2010 through May 2010, C.B. received five times the prescribed dose.

6. The dispensing error was found when C.B.'s father brought the prescription in to be refilled in May 2010.

7. Respondent was the pharmacist on duty at the time the prescription was improperly filled. Respondent was also the pharmacist who reviewed the prescription when the prescription was brought in for a refill. Respondent called C.B.'s father and pediatrician to report the dispensing error. Respondent has been licensed for ten (10) years and this is the first opportunity to respond to a complaint regarding his practice.

CONCLUSIONS OF LAW

1. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. §450.10, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described above constitutes a violation of Wis. Admin. Code Phar § 10.03(2) and subjects Respondent to discipline pursuant to Wis. Stat. § 450.10(1).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Paul Schlondrop, R.Ph. is hereby REPRIMANDED.

2. Respondent shall, within ninety (90) days from the date of this Order, pay a FORFEITURE in the amount of TWO HUNDRED FIFTY DOLLARS (\$250.00), pursuant to Wis. Stat. § 450.10(2).

3. Respondent shall, within ninety (90) days from the date of this Order, pay COSTS of this proceeding in the amount of FOUR HUNDRED FIFTY DOLLARS (\$450.00).

4. All requests, notice, payments required by this Order shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed, faxed, or delivered to:



5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs or payment of the forfeiture as ordered, the Respondent's license (#13328-040) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the payment of the costs or forfeiture.

6. This Order is effective on the date of its signing.
