The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent Jasmine M. Flowers is licensed in the state of Wisconsin as a Barbering and Cosmetology Manager, license number 81-33048. This license was first granted to her on 11/13/2009 and it is current through 03/31/2011.
- 2. The most recent address on file with the Wisconsin Department of Regulation and Licensing (Department) for Respondent Flowers is 4800 West Burleigh Street, Milwaukee, WI 53210.

- 3. In April 2009, the Department received a complaint alleging unlicensed practice at Alamode Barber & Beauty Salon (Alamode) in Milwaukee, Wisconsin. A case was subsequently opened for investigation on or about May 26, 2009.
- 4. On May 21, 2009, a Department Investigator made an unannounced visit to Alamode and performed an inspection. The inspection revealed the following:
 - a. Jasmine Flowers was working with an expired practitioner license, number 82-89186. This license expired on 03/31/2009.
- 5. On July 17, 2009, a Department investigator performed another inspection of Alamode. The inspection revealed the following:
 - a. Jasmine Flowers was still working with an expired practitioner license, number 82-89186. This license expired on 03/31/2009.
- 6. Further investigation revealed that Respondent Jasmine M. Flowers was granted a Barbering and Cosmetology Manager license on November 13, 2009.
- 7. In resolution of this matter, Respondent Jasmine M. Flowers consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the above Findings of Fact, Respondent Jasmine M. Flowers has violated:
 - a. Wis. Stat. § 454.04(1)(a) and Wis. Admin. Code § BC 2.04(1) by participating in unlicensed practice of barbering and cosmetology.
- 3. As a result of the violation noted in paragraph 2 of the Conclusions of Law, Respondent Jasmine M. Flowers is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent Jasmine M. Flowers (license number 81-33048) is hereby REPRIMANDED.

IT IS FURTHER ORDERED that:

2. Respondent Jasmine M. Flowers shall pay a FORFEITURE in the amount of FIVE HUNDRED DOLLARS (\$500.00) and COSTS in the amount of TWO HUNDRED

FIFTY-FIVE DOLLARS (\$255.00) for a total of SEVEN HUNDRED FIFTY-FIVE DOLLARS (\$755.00).

- 3. A down payment of TWO HUNDRED FIFTY-FIVE DOLLARS (\$255.00) shall be paid within 30 days from the date of this Order and two (2) more payments of TWO HUNDRED FIFTY DOLLARS (\$250.00) shall be due every ninety (90) days from the date of the previous due date until the full SEVEN HUNDRED FIFTY-FIVE DOLLARS (\$755.00) is paid in full.
- 4. Payment of the costs and forfeiture shall be made payable to the Wisconsin Department of Regulation and Licensing and sent to:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs and forfeiture as ordered and as set forth above, Respondent's license (number 81-33048) may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs and forfeiture.
 - 6. This Order is effective on the date of its signing.
