The Pharmacy Examining Board considered this matter at its meeting on April 6, 2011.

#### BACKGROUND

On May 25, 2010, Mr. Michael Vande Zande, Pharmacist License #11551-40, surrendered his Wisconsin Pharmacist license. On May 31, 2010, Mr. Vande Zande's Wisconsin Pharmacist license expired and was not timely renewed.

On or about December 13, 2010, Mr. Vande Zande petitioned the Board to reinstate his Wisconsin Pharmacist license.

Based upon all the information of record, the Board orders the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that Mr. Vande Zande's petition for reinstatement, be and hereby is, Denied. In order for the Board to consider reinstatement, the Respondent needs to demonstrate that he has completed at least 30 hours of continuing education, as required by 450.085, Wisconsin Statutes, between June 1, 2008 and the present to demonstrate that he would have been eligible for renewal had he chosen to renew. If the Respondent has his license reinstated in the future, he may not use any of the continuing education credits used to satisfy this requirement to satisfy his continuing education requirements for the 2010-2011 biennium.
