#### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

### **FINDINGS OF FACT**

1. Ashley Renee Kuk, L.P.N., (D.O.B. 4/27/1983) is licensed as a professional nurse in the State of Wisconsin (license # 31-306813). This license was first granted on February 8, 2006.

- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 67078 150<sup>th</sup> Ave. Wabasha, MN 55981.
- 3. On October 8, 2009 the State of Minnesota issued a Consent Order reprimanding Respondent for practicing in Minnesota without a Minnesota license and without requesting recognition by the Minnesota Board of her Wisconsin nursing license from July 2007 to May 20, 2009.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraph 3 above constitutes a violation of Wis. Admin. Code § N 7.04(7).

#### <u>ORDER</u>

#### IT IS ORDERED:

- 1. Ashley Kuk, L.P.N., is REPRIMANDED.
- 2. Respondent shall, within ninety (90) days of the date of this Order, pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$100, pursuant to Wis. Stat. § 440.22(2).

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that Respondent fails to pay costs as ordered, Respondent's license

may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

5. This Order is effective on the date of its signing.
