The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Thomas P. Wentland, M.D., Respondent, date of birth September 18, 1956, is licensed and currently registered by the Wisconsin Medical Examining Board to practice medicine and surgery in the state of Wisconsin pursuant to license number 41908-20, which was first granted on February 4, 2000. Respondent's license to practice medicine and surgery in Wisconsin is current through October 31, 2011.
- 2. Respondent's address of record with the Department of Regulation and Licensing is 2017 Evans Ave., Loves Park, IL 61111.
- 3. On May 20, 2008, the State of Illinois, Department of Financial and Professional Regulation, Division of Professional Regulation placed Respondent's license to practice medicine in that state on probation for two years, and fined him \$2,000.00; Respondent's

controlled substance license was suspended for thirty days, and placed on one year probation. The Illinois authorities found that Respondent had permitted an unlicensed individual to write prescriptions for anabolic steroids and failed to maintain medical records for the five patients for whom the prescriptions were written.

- 4. Respondent's license to practice medicine and surgery in Illinois is current until July 31, 2011; it was restored to full status on May 19, 2010.
- 5. On February 18, 2009, after a hearing in which Respondent was represented by counsel, the State of New York, Department of Health, State Board for Professional Medical Conduct revoked Respondent's license to practice medicine because Respondent had been disciplined in another jurisdiction (Illinois).

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3) and authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent, by engaging in the conduct as set out above, has had a license to practice medicine and surgery granted by another state become subject to adverse actions by licensing authorities in two states, has committed unprofessional as defined by Wis. Admin. Code § MED 10.02(2)(q) and is subject to discipline pursuant to Wis. Stat. § 448.02(3).

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the license to practice medicine and surgery and registration of Thomas P. Wentland, M.D. is hereby REPRIMANDED.

IT IS FURTHER ORDERED that, within 60 days from the date of this Order, Respondent shall pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$250.00, pursuant to Wis. Stat. § 440.22(2).

2. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as set forth above, the Respondent's license (no. 41908-

20) may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.

3. This Order is effective on the date of its signing.

### Division of Enforcement Case No. 10MED285

It is hereby stipulated and agreed, by and between Thomas P. Wentland, M.D., Respondent, and Sandra L. Nowack, attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

- 1. This Stipulation is entered into as a result of a pending investigation of Respondent's licensure by the Division of Enforcement (Case No. 10MED285). Respondent consents to the resolution of this investigation by stipulation and without the issuance of a formal complaint.
- 2. Respondent understands that by signing this Stipulation, he voluntarily and knowingly waives his rights, including: the right to a hearing on the allegations against him, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against him; the right to call witnesses on his behalf and to compel their attendance by subpoena; the right to testify himself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to him under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and any other provisions of state or federal law.
- 3. Respondent has been provided an opportunity to obtain advice of legal counsel prior to signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Board. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's Order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement and any member of the Board ever assigned as a case advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, if any, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with the Board's deliberations on the Stipulation. Additionally, any such case advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Enforcement joins Respondent in recommending that the Board adopt this Stipulation and issue the attached Final Decision and Order.
