PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Dennis Dean Glawe, D.O. (D.O.B.: June 21, 1949), holds a license to practice medicine and surgery in the State of Wisconsin (#26655-21) which was first granted on April 19, 1985. Respondent's registration to practice under that license expires February 29, 2012.

- 2. Respondent's most recent address on file with the Wisconsin Medical Examining Board is P.O. Box 538, Calmar, Iowa 52132. Upon information and belief, Respondent now resides at 24413 Pickwick Loop Road, Winona, Minnesota 55907-5861.
- 3. On December 16, 2010, the Iowa Board of Medicine issued a Statement of Charges and Settlement Agreement (Combined) in which Respondent agreed to voluntarily surrender his license to practice medicine and surgery in the State of Iowa. The basis for the voluntary surrender was as follows:
 - a. In October 1996, the Iowa Board charged Respondent with engaging in a voluntary sexual relationship with a female patient over a period of several months in early 1996.
 - b. More recently, the Board received information which indicated that Respondent had once again engaged in an inappropriate sexual relationship with a female patient.
- 4. The Respondent has retired from the practice of medicine and no longer intends to practice medicine and surgery in Wisconsin.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

NOW, THEREFORE, IT IS ORDERED that:

1. The SURRENDER by Dennis D. Glawe, D.O., Respondent, of his license to practice medicine and surgery in the State of Wisconsin and his right to renew that license is hereby ACCEPTED, effective the date of this Order.

IT IS FURTHER ORDERED that:

- 2. Respondent shall not practice or attempt to practice medicine or surgery in the State of Wisconsin when not currently licensed. Should Respondent ever makes application to the Board for any credential:
 - a. The Board may, in its sole discretion determine whether, and under what terms and conditions, a license may be reissued.

- b. Respondent shall, prior to becoming credentialed, pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$200.00, pursuant to Wis. Stat. § 440.22(2).
