BACKGROUND

On May 18, 2011, the Medical Examining Board (Board) issued a Final Decision and Order limiting the license to practice medicine and surgery of Donald J. Hennessy, Jr., M.D., (23781-20) by prohibiting him from prescribing narcotic substances and requiring him to transfer all patients requiring pain medication to another licensed physician to address the patient's pain management.

On or about July 18, 2011, Dr. Hennessy petitioned the Board for removal of the limitations. Dr. Hennessy appeared before the Board in support of his petition at its August 17, 2011 meeting. Based upon the information of record, the Board now finds and makes the following:


ORDER

NOW, THEREFORE, IT IS ORDERED that the request to remove all restrictions from the license to practice medicine and surgery of Donald J. Hennessy Jr., M.D., be, and hereby is, DENIED.

IT IS FURTHER ORDERED that Dr. Hennessy may not repetition the Board for full licensure for one year from the date of this order.
