Failure of Respondent to make payment on or before March 1, 2012, shall constitute a violation of the Order unless Respondent petitions for and the Board grants a different deadline. Under § 440.22(3), Wis. Stats., the Department of Safety and Professional Services may not restore, renew or otherwise issue any credential to the Respondent until Respondent has made payment to the Department in the full amount assessed.
