The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Regulation and Licensing ("Department"). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Respondent Nicholas A. Wilcox is licensed in the State of Wisconsin as a Private Security Person, having license number 108-32856, first issued on 02/19/2007 and current through 08/31/2012. Mr. Wilcox's most recent address on file with the Department is 714 Sunnyslope Drive, Apt. 2, Hartland, WI 53029.
- 2. On or about July 6, 2010, Mr. Wilcox submitted a renewal application to the Department and answered "NO" to the following question:

HAVE YOU BEEN CONVICTED WITHIN THE PAST TWO YEARS OF A FELONY, A MISDEMEANOR OR A VIOATION OF ANY STATE OR LOCAL LAW (OTHER THAN TRAFFIC) THAT IS PUNISHABLE BY A FORFEITURE, OR, ARE CHARGES PENDING? (If YES, provide information.)

- 3. A Criminal Information Bureau check revealed a conviction for Mr. Wilcox within the two years preceding July 6, 2010.
- 4. Court records obtained during the course of the Department's investigation revealed that on or about July 2, 2010, Mr. Wilcox was convicted of an ordinance violation, Disorderly Conduct.
  - 5. Mr. Wilcox provided false information in his application to renew his credential.
- 6. The circumstances of Mr. Wilcox's disorderly conduct conviction substantially relate to the practice of a private security person.

#### CONCLUSIONS OF LAW

- 1. The State of Wisconsin Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent Nicholas A. Wilcox has violated Wis. Admin. Code § RL 35.01(17) by providing false information in the application for a credential.
- 3. Respondent Nicholas A. Wilcox has engaged in conduct reflecting adversely on his professional qualification pursuant to Wis. Admin. Code § RL 35.01(2) by violating a law the circumstances of which substantially relate to the practice of a private security person.
- 4. As a result of the violations noted in the Conclusions of Law, Respondent Nicholas A. Wilcox is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)(1)1., 2., and 3., as well as Wis. Admin. Code § RL 35.01.

#### **ORDER**

#### NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. Respondent Nicholas A. Wilcox is hereby REPRIMANDED.
- 2. Within ninety (90) days following the date of this Order, Respondent Nicholas A. Wilcox shall pay COSTS in the amount of THREE HUNDRED TWENTY-FIVE DOLLARS (\$325.00).
- 3. Payment of the costs shall be made payable to the Wisconsin Department of Regulation and Licensing and sent to:

- 4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent Nicholas A. Wilcox fails to timely submit payment of the costs as ordered and as set forth above, Respondent Wilcox's license (number 108-32856) may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
  - 5. This Order is effective on the date of its signing.
