IN THE MATTER OF DISCIPLINARY PROCEEDINGS AGAINST DEVONTES D. HARRIS ORDER FIXING COSTS Order 0000955 08 RSG 025

On July 15, 2011, the Department of Safety and Professional Services issued its Final Decision and Order in the above-captioned matter, revoking Respondent's license to practice as a private security person in Wisconsin, and revoking his right to renew such license. By its authority under s. 440.22, Wis. Stats., the Department also ordered that Respondent pay the costs of this proceeding. On or about July 22, 2011, the Department received an affidavit of costs in the amount of \$4,648.87, filed by the prosecuting attorney, Peter McCombs. On or about July 27, 2011, the Board received an affidavit of costs in the amount of \$542.90 filed by Administrative Law Judge Amanda Tollefsen of the Department of Administration, Division of Hearings and Appeals. The Department of Safety and Professional Services has considered the affidavits of costs, and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the combined amount of \$5,191.77, as set forth in the affidavits of costs of Attorney Arthur Thexton and Administrative Law Judge Amanda Tollefsen, attached hereto and made a part hereof, are assessed against Respondent. Failure to pay the full amount assessed within 90 days of the date of this Order shall constitute a violation of the Order unless Respondent petitions for, and the Department grants, a different deadline. Under sec. 440.22 (3), Wis. Stats., the Department of Safety and Professional Services may not restore, renew, or otherwise issue any credential to Respondent until he has paid the full amount assessed.
