The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Susan M. Trefny, R.N., (DOB 11/05/1950) is licensed as a professional nurse in the State of Wisconsin (license # 30-130846). This license was first granted on October 6, 1998.
2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 3524 7<sup>th</sup> Ave. Apt 121, Kenosha, WI 53140.

3. On January 25, 2011, the Department of Financial and Professional Regulation, Division of Professional Regulation of the State of Illinois, issued an order indefinitely suspending Respondent's license for violating a previous consent order that was issued on July 25, 2007. The 2007 Consent Order suspended Respondent's license for six months with indefinite probation immediately following for a minimum of three years because Respondent diverted controlled substances from her employer for self use.

#### CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraph 3 above constitutes misconduct or unprofessional conduct pursuant to Wis. Admin. Code §§ N 7.04(2) and (7) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

#### ORDER

#### IT IS ORDERED:

1. The VOLUNTARY SURRENDER of the license of Susan M. Trefny to practice nursing in the State of Wisconsin is hereby accepted.

2. The VOLUNTARY SURRENDER of the privilege of Susan M. Trefny to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. Susan M. Trefny shall not apply to renew, reinstate or obtain any license to practice nursing in Wisconsin.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of \$232.58. Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:
