On June 20, 2011, the Medical Examining Board filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., full costs of this proceeding be assessed against respondent. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about July 28, 2011, the Medical Examining Board received the Affidavit of Costs in the amount of \$846.99 filed by Attorney Sandra Nowack. On or about August 10, 2011, the Medical Examining received the Affidavit of Costs of the Division of Hearings and Appeals in the amount of \$323.30, filed by Administrative Law Judge Amanda Tollefsen. The Medical Examining Board considered the Affidavits of Costs on September 21, 2011, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the full costs of this proceeding in the amount of \$1, 170.29, set forth in the Affidavits of Costs of Attorney Sandra Nowack and Administrative Law Judge Amanda Tollefsen, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by respondent to the Department of Safety and Professional Services. **Failure of respondent to make payment on or before December 20, 2011, shall constitute a violation of the Order unless respondent petitions for and the board grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Wisconsin Department of Safety and Professional Services may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.


