The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Wisconsin Department of Regulation and Licensing ("Department"). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Respondent Gurda Enterprises, Ltd. d/b/a United Security Services ("Gurda Enterprises") is licensed in the State of Wisconsin as a Private Detective Agency, having license number 62-6160, first issued on August 30, 1979 and current through August 31, 2011. Gurda Enterprises' most recent address on file with the Department is P.O. Box 210125, Milwaukee, Wisconsin 53221.
- 2. On at least two occasions in 2009, Gurda Enterprises issued paychecks on Gurda Enterprises business accounts to Gurda Enterprises employees that were returned for insufficient funds.

3. In resolution of this matter, Gurda Enterprises consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in Finding of Fact 2 reflects adversely on Gurda Enterprises' professional qualifications pursuant to Wis. Admin. Code § RL 35.01(15).
- 3. As a result of the above conduct, Gurda Enterprises is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)2 and Wis. Admin. Code §§ RL 35.01 and 35.02.

#### <u>ORDER</u>

#### NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached stipulation is hereby accepted.
- 2. The Private Detective Agency license of Respondent Gurda Enterprises, Ltd. d/b/a United Security Services (number 62-6160) is hereby REPRIMANDED.
- 3. Respondent Gurda Enterprises, Ltd. d/b/a United Security Services shall, within one hundred and eighty (180) days of the date of this Order, pay COSTS of this matter in the amount of EIGHT HUNDRED NINETY FOUR DOLLARS (\$894.00).
- 4. Payment of the costs (made payable to the Wisconsin Department of Regulation and Licensing) shall be sent to the Department Monitor at:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered and as set forth above, its license (number 62-6160) may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
  - 6. This Order is effective on the date of its signing.
