## **Procedural History**

The Division of Enforcement filed the complaint that became DHA case SPS 10-0102 on December 23, 2010, and the complaint that became DHA case SPS 11-0065 on July 29, 2011. Administrative Law Judge Amanda Tollefsen was assigned to both cases. Respondent Lawrence Kane, by attorney Richard Lewandowski and Whyte Hirschboeck Dudek, timely filed Answers in both matters. Prehearing conferences were held, and the matters were set for hearing on October 3, 4, and 5, 2011. The parties reached a resolution, and presented it to the Section for its consideration. The Section considers the resolution acceptable, and makes the following:

### **Findings of Fact**

- 1. Lawrence Kane, III, L.C.S.W., Respondent, date of birth August 16, 1956, is licensed as a Licensed Clinical Social Worker pursuant to license number 3138-123, which was first granted on December 19, 1994.
- 2. Respondent's last address reported to the Department of Safety and Professional Services is 7170 N. Port Washington Road, Glendale, WI. 53217.
- 3. Since at least 2000, Respondent has been the owner and director of Wisconsin Community Mental Health Counseling Centers, Inc. (WCMHCC), an entity that provides outpatient mental health services at several locations in Wisconsin.
  - 4. The formal disciplinary complaint against Respondent alleges that he
    - · engaged in false advertising,
    - permitted an unlicensed person to practice psychotherapy,
    - engaged in misleading business and billing practices to the detriment of his patients;
    - intentionally violated patient confidences;
    - failed to comply with State regulations governing the operation of private psychotherapy practices;
    - engaged in the negligent practice of psychotherapy by conducting sessions in public places and while simultaneously engaged in personal errands; and
    - engaged in non-sexual prohibited dual relationships with patients.
- 5. Respondent denies that any of his conduct violated any of the standards or rules governing the practice of a social worker but has decided to retire from practice, and in order to avoid the expense, delays and uncertainties of an administrative hearing, has agreed to resign his license.

#### Conclusions of Law

- 1. The Social Workers Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board has jurisdiction in this matter pursuant to Wis. Stat. § 457.26.
- 2. Respondent's conduct as alleged in the formal complaint violated Wis. Admin. Code § MPSW 20.02 and is subject to discipline pursuant to Wis. Stat. § 457.26(2)(f).

#### Order

Now, therefore, it is ORDERED that

- 1. The Social Workers Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board accepts the resignation and surrender of Respondent's license, together with all rights to reinstatement.
- 2. Within 90 days of the date of this Order, Respondent shall pay costs of the proceeding in the amount of \$1075.00 (One thousand seventy-five dollars).
- 3. This Order is effective on the date of its signing.
