PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Jan Rosnow, M.D., Respondent (D.O.B.: May 15, 1952), is licensed and currently registered by the Wisconsin Medical Examining Board to practice medicine and surgery in the state of Wisconsin pursuant to license number 23499-20, which was first granted on October 17, 1980.
- 2. Respondent's last address reported to the Department of Regulation and Licensing is 791 Crocker Road, Sacramento, CA 95864.

3. On March 2, 2010, the Medical Board of California, Department of Consumer Affairs and Respondent entered into a Stipulated Settlement and Disciplinary Order. The Order was based upon the following standard of care violation:

On or about October 11, 2006, Respondent administered succinylcholine to patient C.H. who had suffered a recent spinal cord injury. Succinylcholine can be contraindicated for patients with recent spinal cord injuries. The patient suffered cardiac arrest which resulted in anoxic brain injury and subsequent death

- 4. The Order reprimanded Respondent and required her to:
 - a. Within 60 days of the Order, enroll in and complete in a course in prescribing practices.
 - b. Within 60 days of the Order, enroll in a clinical training or educational program equivalent to the Physician Assessment and Clinical Education Program (PACE) at the University of California. Respondent will comply with program recommendations and pass an examination.
- 5. As of November 2, 2010, Respondent fully complied with the terms and conditions of the Medical Board of California's Stipulated Settlement and Disciplinary Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3) and authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent, by having her practice credential limited by the Medical Board of California, Department of Consumer Affairs, has committed unprofessional conduct as defined by Wis. Admin. Code §§ Med 10.02(2)(q), and is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

IT IS HEREBY ORDERED that the attached Stipulation of the parties is accepted.

IT IS FURTHER ORDERED that:

- 1. Jan Rosnow, M.D., Respondent, is hereby REPRIMANDED for the above conduct.
- 2. Respondent shall within 90 days of this Order pay costs of this proceeding in the amount of THREE HUNDRED AND EIGHTY (\$380.00) dollars. Payment shall be made to the Wisconsin Department of Regulation and Licensing, and mailed to:

- 3. Violation of any terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, the Respondent's license (No. 23499-20) may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
 - 4. This Order is effective on the date of its signing.
