The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Jennifer L. Pudlewski (D.O.B. 07/24/1975) is duly licensed in the state of Wisconsin as a professional nurse (license # 30-142340). This license was first granted on August 14, 2002.

2. On January 28, 2011, the Department of Financial and Professional Regulation of the State of Illinois, Division of Professional Regulation ("DFPR"), approved a Consent Order placing Respondent's Certificate of Registration, license no. 041-330135, on probationary status for three years.

3. The Consent Order was based on Respondent, while working at a hospital in Chicago, IL, failing to chart the administration of medication, charting before administering some medications, and wasting medication without having a witness.

#### CONCLUSION OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described above constitutes a violation of Wisconsin Administrative Code § N 7.04(7) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

#### ORDER

##### IT IS ORDERED:

1. The SURRENDER of the license of Jennifer L. Pudlewski to practice nursing in the State of Wisconsin is hereby accepted.

2. The SURRENDER of the privilege of Jennifer L. Pudlewski to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of two hundred dollars (\$350.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:


