PROCEDURAL HISTORY

On September 21, 2011, the Wisconsin Social Work Examining Board adopted the Proposed Final Decision and Order in the Matter of the Application for Certification as a Social Worker in Training, Cassie L. Hubanks, dated August 11, 2011. The Administrative Law Judge (ALJ), conducted a Class 1 hearing on July 6, 2011, and found that the denial of Ms. Hubanks' application was based upon a material mistake of fact because the evidence presented demonstrated that Ms. Hubanks' work experience satisfied the Social Work Training Certificate requirements. Accordingly, the ALJ remanded Ms. Hubanks' application to the Social Work Section for a decision consistent with the facts presented in the supervisor affidavit of Ms. Colleen Teynor and the testimony which she presented at the hearing. Based upon the findings and order of remand in the proposed decision, which were duly adopted by the Social Work Section, the following order is now made:

ORDER

NOW, THEREFORE, IT IS ORDERED that the application OF CASSIE L. HUBANKS for social work certification in the state of Wisconsin is hereby GRANTED; subject to her completion of any remaining requirements under the Social Work Training Certificate.

IT IS FURTHER ORDERED that the contingency for approval of Ms. Hubanks' application for certification does not operate as an extension of the training certificate, but merely serves to allow the applicant to take the required examinations and complete any application form requirements.
