The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Brian C. Zastrow, R.N., (DOB 08/21/78) is licensed as a professional nurse in the State of Wisconsin (license no. 143382-30). This license was first granted on March 6, 2003.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is W174 S. Timber Lane, Sullivan, WI 53178.

3. On August 2, 2010, Respondent signed a Professional Assistance Procedure ("PAP") Contract after admitting to diverting and using narcotics while at work.

4. On July 29, 2011, the PAP coordinator contacted Respondent due to his failure to enroll for testing and submit quarterly reports pursuant to the PAP Contract. Respondent contacted the PAP coordinator advising him that he no longer wants to participate in PAP.

### CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described above constitutes a violation of Wisconsin Administrative Code §§ N 7.03(2) and N 7.04(2) and subjects Respondent to discipline pursuant to Wis. Stat. §§ 441.07(1)(c) and (d).

### ORDER

#### IT IS ORDERED:

1. The SURRENDER of the license of Brian C. Zastrow to practice nursing in the State of Wisconsin is hereby accepted.

2. The SURRENDER of the privilege of Brian C. Zastrow to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent re-applies for licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of two hundred dollars (\$200.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services, and mailed to:


