ORDER OF SUMMARY SUSPENSION

Division of Enforcement Case No. 11MED308

The Petition for Summary Suspension of October 14, 2011 was noticed to be presented at 8:15 a.m., or as soon thereafter as the matter could be heard, on October 19, 2010. At that time, attorney Aaron A. Konkol appeared for the Complainant, Department of Safety and Professional Services, Division of Enforcement. Respondent appeared in person and with counsel.

The Wisconsin Medical Examining Board, having considered the sworn October 14, 2011 Petition for Summary Suspension, and the October 17, 2011 Affidavit of Service of Notice of Presentation and Petition for Summary Suspension of Ashley Horton, and having heard the arguments of counsel, hereby makes the following:

FINDINGS OF FACT

1. Gregory Goetz, M.D., Respondent, date of birth January 17, 1954, is licensed by the Wisconsin Medical Examining Board (Board) to practice medicine and surgery in the State of Wisconsin, pursuant to license number 23351-20, which was first granted on August 5, 1980. Respondent specializes in family practice.
2. Respondent's last address reported to the Department of Safety and Professional Services is 9431 W. Beloit Road, #119, Milwaukee, WI 53227. Upon information and belief, Respondent's actual address is 6991 South Lover's Lane, Franklin, Wisconsin, 53132
3. On October 14, 2011, copies of the October 14, 2011 Notice of Presentation and Petition for Summary Suspension were properly served on Respondent, as required by Wis. Admin. Code § RL 6.05, by mailing them by regular and certified mail to Respondent's addresses listed above.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3) and has authority to summarily suspend Respondent's license to practice medicine and surgery in the State of Wisconsin, pursuant to Wis. Stats. §§ 227.53(3) and 448.02(4) and Wis. Admin. Code § RL 6.

2. There is probable cause to believe that Respondent violated Wis. Stat. § 448.02(3) and Wis. Admin. Code § Med 10.02(2)(i), by committing unprofessional conduct.

3. It is imperatively required and necessary to suspend Respondent's license to practice medicine and surgery immediately to protect the public health, safety and welfare.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of Gregory Goetz, M.D., to practice medicine and surgery in the state of Wisconsin be and is summarily suspended effective immediately and shall remain suspended until the effective date of a final decision and order issued in the disciplinary proceeding against Respondent.

IT IS FURTHER ORDERED that a Notice of Hearing commencing a disciplinary proceeding shall be issued no more than 10 days following the issuance of this Order of Summary Suspension.

IT IS FURTHER ORDERED that Respondent is hereby notified of his right, pursuant to Wis. Admin. Code § RL 6.09, to request a hearing to show cause why this summary suspension order should not be continued and is further notified that any request for a hearing to show cause should be filed with the Wisconsin Medical Examining Board, 1400 East Washington Avenue, P.O. Box 8935, Madison, WI 53708.

IT IS FURTHER ORDERED that in the event that Respondent requests a hearing to show cause why the summary suspension should not be continued, that hearing shall be scheduled to be heard on a date within 20 days of receipt by the Board of Respondent's request for hearing, unless Respondent requests or agrees to a later time for the hearing.
