The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Catherine D. Prange, L.P.N., (DOB 05/23/1964) is licensed as a practical nurse in the State of Wisconsin (license no. 311143-31). This license was first granted on July 17, 2009.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is W224S1580 Whitehall Street, Waukesha, WI 53186.

3. On July 15, 2011, the Illinois Department of Financial and Professional Regulation, Division of Professional Regulation, issued an order suspending Respondent's license to practice as a registered nurse in the State of Illinois related to the 1987 incident involving the diversion of narcotics for personal use.

4. Respondent is not currently employed or practicing as a nurse, and desires to surrender her license.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraphs 3 and 4 above constitutes a violation of Wisconsin Administrative Code §§ N 7.04(2) and (7) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

1. The SURRENDER of the license of Catherine D. Prange to practice nursing in the State of Wisconsin is hereby accepted.

2. The SURRENDER of the privilege of Catherine D. Prange to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent re-applies for licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of three hundred fifty dollars (\$350.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services, and mailed to:
