PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Kaye P. Churchill, R.N., (DOB 11/13/1958) is licensed as a professional nurse in the State of Wisconsin (license no. 75046-30). This license was first granted on November 30, 1979.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 3319 Minnow Bucket Road, Toonsuba, MS 39364.

3. On June 8, 2011, the Mississippi Board of Nursing and Respondent entered into an Agreed Order ("Order") that restricted Respondent's licensure for a minimum of 24 months.

4. The Order was based on Respondent submitting to a reasonable suspicion drug screen, which was positive for Propoxyphene. Respondent did not have a prescription for Propoxyphene.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraph 3 above constitutes a violation of Wisconsin Administrative Code § N 7.04(7) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

1. The SURRENDER of the license of Kaye P. Churchill to practice nursing in the State of Wisconsin is hereby accepted.

2. The SURRENDER of the privilege of Kaye P. Churchill to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent re-applies for licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of six hundred dollars (\$600.00).
