The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Jennifer J. Plaza, R.N., (D.O.B. 4/30/1984) is licensed as a professional nurse in the State of Wisconsin (license # 30-158779). This license was first granted on August 15, 2007.
2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 2549 N. Lake Drive, Apartment 7, Milwaukee, WI 53211.

3. On June 3, 2010, the Minnesota Board of Nursing (Minnesota Board) and the Respondent entered into a Stipulation and Consent Order related to allegations of the Respondent's record keeping discrepancies and documentation errors between May and June of 2009.

4. Respondent was subjected to discipline by the Minnesota Board and herein agrees to similar limitations and agrees to provide the Wisconsin Board of Nursing with all documentation and full proof of compliance with the terms of the Minnesota Board Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraph 3 above constitutes a violation of Wisconsin Administrative Code § N 7.04(7) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

1. Jennifer J. Plaza, R.N., Respondent, is hereby REPRIMANDED for the above conduct.

2. Respondent is to maintain full and complete compliance with all terms, limitations, and conditions imposed against her nursing license by the Minnesota Board of Nursing.

3. Respondent shall provide the State of Wisconsin Board of Nursing with a copy of any document issued by the Minnesota Board of Nursing which alters the conditions of Respondent's continued practice as a nurse in the State of Minnesota, including any document advising reinstatement of full licensure.

4. Respondent shall report to the Wisconsin Board of Nursing, or its designee, any changes in the status of her license with the Minnesota Board within 10 days of the change imposed by the Minnesota Board.

5. Respondent shall within 90 days of this Order pay costs of this proceeding in the amount of four hundred (\$400.00) dollars. Payment shall be made to the Wisconsin Department of Safety and Professional Services, and mailed to:

6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety, and welfare and may result in summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to make timely payment of costs or fails to provide the Department with proof of compliance with the terms as set forth above, Respondent's license (#30-158779) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with this Order.

7. This Order is effective on the date of its signing.
